Applications will be accepted Online only: Offline applications or hard copies will not be accepted by the Ministry.

### **Important Instructions**

- The detailed steps for filling up of the Online Application forms can be downloaded from "What's New" on the
  Ministry's website www.minorityaffairs.gov.in. Online Application may be filled accordingly and a printout may be
  taken, which may be submitted to the District Collector/District Magistrate/Deputy Commissioner along with the 'one page
  format' prescribed for recommendation of District Collector/District Magistrate/Deputy Commissioner and credentials. The
  prescribed 'one page format' is available under "Forms" on the OAMS, which may be downloaded.
- To reach to OAMS, the Link/Icon "Nai Roshni" on the Ministry's website may be clicked.
- District Collector/District Magistrate/Deputy Commissioner, while recommending the organization, will also have to
  endorse a copy to the President/Secretary of the applicant organization. the organization may upload the scanned copy of
  the Recommendation Letter on the portal and "Confirm" submission of online application.
- On submission of online application, an Application ID and date of submission would be generated which the organization
  must keep with them for future reference.
- The status of applications, empanelment, updates about approvals, sanctions, releases etc. would be made available on the portal OAMS only.
- One organization will fill only one online application for a District empanelment. For each district, separate
  recommendation of District Collector/District Magistrate/Deputy Commissioner would be mandatory. However,
  consideration of application from an organization for empanelment for more than one District will be entirely the decision of
  Ministry. The decision of the Ministry in this regard shall be final and binding on the organization.
- The Organization should be enrolled with NITI Aayog NGO Darpan Portal.
- The organizations who have implemented the project under the scheme earlier have to apply afresh with District Recommendation and requisite documents. They will be considered as fresh applicant for the years 2017-20 selection process.
- Ministry of Minority Affairs reserves the right, without any obligation or liability, to accept or reject any or all of the proposals
  at any stage of the process, to cancel or modify the process or any part thereof, or to vary any of the terms and conditions at
  any time without assigning any reasons thereof.
