
Subject: Grant in aid for setting up of an IT Enabled Dedicated Cell in one at State Department i.e., Assam and one at Directorate and 12 in Dy. Commissioner Offices under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of Assam for the year 2010-11.

Sir,

In continuation to this Ministry's sanction letter of even no. dated 4.12.2009 & 30.3.2010 for release of setting up of an IT Enabled Dedicated Cells, I am directed to convey the sanction of the President for release of an amount of Rs. 23, 40,000/- (Twenty Three lakhs and Forty thousand only) for the running and maintenance of IT Cell to the Govt. of Assam at one State Department i.e., Assam and one at Directorate and 12 in Dy. Commissioner offices to monitor the implementation of the scheme "Multi Sectoral Development Programme for minorities" in the State of Assam as per the details enclosed at **Annexure-I**. The non-recurring grant may be released to the Govt. of Assam through CAS, Reserve Bank of India, Nagpur.

The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -other grants, 04 - Multi sectoral Development Programme for minorities, 04.00.31 - Grant-in-aid-General for the year 2010-11.
3. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. Utilization Certificate of Rs 12.90 lakh has been received (copy enclosed). No further UC is pending.
4. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
5. This sanction issues with concurrence of IFD vide their Dy. No. 893/IFD dated 20/1/2011. It is noted at S.No. 7 in the Grant-in-aid Register.


