- 3. Since it is a fresh release for the revised plan, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of the financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame, should also be furnished.
- 4. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
- 5. The ITI is to be constructed as per the estimates prepared as per Schedule of Rates of the State Government approved by the competent engineering department contained in the DPR submitted to the Ministry and advice given by the Ministry of Labour & Employment. The amount would be scrupulously deducted if any deviation, is found at any stage of the implementation of the scheme.
