Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of **Uttar Pradesh for the year 2014-15 for Bulandshahr District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 20.03.12 releasing, inter-alia, an amount of Rs. 615.00 lakh, towards Govt. Polytechnic with two hostels at Thagora Madkola Bulandshahr district of Uttar Pradesh, I am directed to convey the sanction of the President for release of an amount of Rs. **6,15,00,000/- (Rupees six crore fifteen lakh only)** as 2<sup>nd</sup> instalment to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Districts" for **Bulandshahr** district as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 - Grant for creation of capital assets for the year 2014-15.

3. A copy of the Utilization certificate of 1<sup>st</sup> instalment is enclosed. Further it is certified that no UC is pending for this project.

4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and the requisitioned amount with milestones and time frame, should also be furnished.

5. It should be ensured that construction of all the components as required under the scheme "Sum-Mission on Polytechnics under Coordinated Action for Skill Development", so that affiliation of AICTE may be obtained smoothly. In this connection this Ministry letter no. 3/31/2012-PP (pt) may also be referred to.
