Sir,

In continuation to this Ministry's sanction letter of even dated 08.01.2014, I am directed to convey the sanction of the President of India for the release an amount of Rs. 1,43,100/- (Rupees One Lakh Forty Three thousand One hundred only), as 2nd installment (40%) of Non-Residential training out of the total sanctioned amount of Rs. 3,57,750/-(Rupees three lakh fifty Seven Thousand seven hundred and fifty only) as Non-recurring grant-in-aid for the year 2013-14 during the year 2014-15, under the scheme for Leadership Development of Minority Women to the Facilitation and Awareness of Community for Empowerment (FACE), 10/135, 6 back of Look house, shiv Nagar, Rewa-486001, MP" on the following terms and conditions:

- 2 (i) Grant-in-aid has been given to the above mentioned organizations on the basis of the recommendation of Government of Madhya Pradesh. It is incumbent on the part of Government of Madhya Pradesh to ensure that the organization recommended by them utilize the fund for the purpose it has been sanctioned.
- (ii) The Organization will not obtain grant for the same purpose or activity from any other Ministry or Department of Government of India or State Government and or any other body.
- (iii) The Organization will not divert grant-in-aid and entrust the execution of the project for which the Grant-in-Aid is sanctioned to an her organization or institution. No funds out of this grant should be utilized for any new/other scheme for which prior approval of Government has not been obtained.

- (v) The Organization will maintain subsidiary accounts of the Government grant and furnish the audited statement of accounts with unitization certificate in GFR 19 (A) at the end of financial year 2014-15 to the Government.
- (vi) The accounts of the Organization shall be open to inspection by the sanctioning and recommending authority and Comptroller and Auditor General of India and Internal Audit Wing of Officer of Chief Controller of Accounts of the Organization is called upon to do so.
- (vii) The assets acquired wholly or substantially out of Government grant should not be disposed of without prior sanction of the esident, encumbered or used for purpose other than those for which grant has been sanctioned. The organization is required to maintain a Register of such assets and send an annual statement in the prescribed proforma to this Ministry at end of the financial year.
- (viii) If the vernment is not satisfied with the progress of the project or considers that the conditions of sanction are being violated, reserves the right to terminate the grant-in-aid and/or to blacklist the organization from future grant or any other finance assistance from the Government, apart from taking appropriate civil and criminal legal action.
- (ix) It is for certified that grant-in-aid to the grantee is sanctioned in accordance with pattern of financial assistance approximately and is in conformity with guidelines of the Scheme.
- (x) The C t-in-Aid is further subject, to the conditions laid down in General Financial Rules as amended from time to time.
- (xi) The G -in-Aid is further subject, to fulfillment of terms and conditions to the provisions including Financial norms as la two in the "Scheme for the Leadership development of Minorities Women" and further instructions/d ins from the Government of India from time to time.
- (xii) As per page 20(e) of the "Scheme for Leadership Development of Minority Women", the organization shall utilize stance for the specified purposes only. The organization shall give an undertaking that in the event of acting in contrastion of this condition, it will refund the amount received from the Government with 18% annual penal interest and an action, as deemed necessary by Government.
- 3. Certify of there is no unspent balance available with the organization.
