Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of **Uttar Pradesh for the year 2011-12 for Ghaziabad District.**

Sir,


In continuation to this Ministry's sanction letter of even number dated 01.07.09, 19.03.10, 21.06.10, 03.12.10, 09.12.10 and 25.10.2011, I am directed to convey the sanction of the President for release of an amount of **Rs.34,25,500/- (Rupees thirty four lakh twenty five thousand five hundred only)** as 1st instalment (50% of total central share) of the total sanctioned amount of **Rs. 68,51,000/- (Rupees sixty eight lakh and fifty one thousand only)** for the year 2011-12 to the Govt. of U.P. for implementing the scheme "Multi Sectoral Development Programme for minority concentration districts" for Ghaziabad district as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share (i.e. Rs. 18.445 lakh) is released to the implementing agency alongwith Central share of Rs. 34.255 lakh.

3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 - Grant for creation of capital assets for the year 2011-12.

4. Since it is a fresh release no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame may also be furnished.

5. This sanction would be subject to the condition to furnishing a certificate from the District Collector or Chief Executive Officer, Zilla Panchayat to the effect that it has not been sanctioned under SSA during the current financial year or previous years and conditions annexed. State Govt. should ensure these conditions are met before starting the work. The

amount would be scrupulously deducted if any deviation is found at any stage of the implementation of scheme.

6. Within the one month of the receipt of the release of the amount conveyed through this sanction order, State Govt. will fulfill the commitment required for the projects mentioned at annex-I and convey acceptance to all the terms and conditions, failing which the Ministry will review the project. The conditions conveyed vide this Ministry's letter of even no. dated 14.12.11 may also be referred to.

7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

8. Funds should be released by the State Govt. to the implementing agencies only after all the conditions stipulated while approving the projects are fulfilled. Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.

10. This sanction issues with concurrence of IFD vide their Dy. No. 881/IFD dated 22.03.12. It is noted at S. No. 196 in the Grant-in-aid Register.

- i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
- ii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
