

The Drawing and Disbursing Officer (DDO), Ministry of Minority Affairs is hereby authorized to draw an amount of Rs. 1,32,82,731/- (Rupees one crore thirty two lakh eighty two thousand seven hundred and thirty one only) as the payment for 2nd installment (25%) to Society for Development & Training.
