Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of Arunachal Pradesh for the year 2011-12 for Lower Subansiri District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 14.12.2010 and 30.03.11, I am directed to convey the sanction of the President for release of an amount of Rs. **1,60,06,000/- (Rupees one crore sixty lakh and six thousand only)** as 2nd instalment (50% of total central share) of the total sanctioned amount of Rs. **3,20,10,000 /- (Rupees three crore twenty lakh and ten thousand only)** for the year 2011-12 to the Govt. of AP for implementing the scheme "Multi Sectoral Development Programme for minority concentration district districts" for Lower Subansiri district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of AP through CAS, Reserve Bank of India, Nagpur.


2. The State Government should ensure that proportionate share of 50% of State share (i.e. Rs. 21.475 lakh) for the projects mentioned at annexure - released to the implementing agency alongwith Central share of Rs. 160.06 lakh.

3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 - Grant for creation of capital assets for the year 2011-12.

4. A copy of the Utilization certificate of 1st instalment is enclosed. Further it is certified that no UC is pending for this programme.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame may also be furnished.

The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.


8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.

10. This sanction issues with concurrence of IFD vide their Dy. No. 712/IFD dated 24.01.2012. It is noted at S. No. 133 in the Grant-in-aid Register.

11. Re-appropriation of fund from the Major Head 2552 to Functional Head 3601 have been carried out with the approval of Secretary (MA), M/o. Minority Affairs vide Dy. No. 218/Secy(MA)/12 dated 02.02.2012 and concurrence of Joint Secretary and Financial Adviser for an amount of Rs.16006000/- (Rupees one crore sixty lakh and six thousand only).

- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
