Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of Uttar Pradesh for the year 2011-12 for Jyotiba Phule Nagar District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 31.12.08, 30.12.09, 03.12.10 and 24.12.10, I am directed to convey the sanction of the President for release of an amount of Rs 62,70,000/- (Rupees sixty two lakh and seventy thousand only) as 1st instalment (50% of total central share) of the total sanctioned amount of Rs. 1,25,40,000/- (Rupees one crore twenty five lakh and forty thousand only) for the year 2011-12 to the Govt. of UP for implementing the scheme "Multi Sectoral Development Programme for minorities" for Jyotiba Phule Nagar district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of UP through CAS, Reserve Bank of India, Nagpur.

- 2. The State Government should ensure that proportionate share of 50% of State share (i.e. Rs. 20.90 lakh) for construction of one Govt. inter-college is released to the implementing agency alongwith Central share of Rs. 62.70 lakh.
- 3. The Inter-colleges shall be constructed as per the drawing and estimates prepared as per the Scheduled of rates of the State Govt. approved by a competent engineering authority.
- 4. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Central Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Bekward Classes) -other grants, 04 Multi sectoral Development Programme for minorities, 04.00.35 Grant for creation of capital assets.
- 5. Since it is fresh release for the revised plan of balance fund, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of the financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount would be furnished for release of second indtallment.
- 6. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
- 7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

- 8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- 9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
- 10. This sanction issues with concurrence of IFD vide their Dy. No. 258/2011/IFD dated 13.10.2011. It is noted at S. No.34 in the Grant-in-aid Register.


