
A copy of the Utilization certificate of 1st instalment is enclosed. Further it is certified that no UC 4. is pending for this programmme.

After completion of projects, a permanent display would be installed.

Funds should be released by the State Govt. to the implementing agencies immediately upon 8. receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.



Utilisation of the above mentioned amount by the State Government is subject to the terms 9 and conditioned at annexure-II.
