Notice inviting proposals under the scheme of

“Research/Studies, Monitoring and Evaluation of Development Schemes including Publicity” for the year 2018-19.

1. **Ministry of Minority Affairs, Government of India, invites proposals under the scheme of “Research/Studies, Monitoring and Evaluation of Development Schemes including Publicity” for the year 2018-19 from eligible organizations/institutions in prescribed format for the following as given below:**
 - (i) **Operation Research/ Market Research/ Action Research including Baseline Survey/Survey, Monitoring/Concurrent Monitoring, Evaluation/ Impact Assessment Studies on the following:-**
 - a. Study the traditional skills/ craft of the minority artisans which are not covered under National Skills Qualifications Framework (NSQF)/Common Norms and make recommendations for reviving and promotion of the languishing and dying skills/crafts.
 - b. Study the implementation of Hunar Haat programme/schemes for artisans and other similar skill exhibitions of other ministries/ organisations and to make recommendations for bringing about further improvements.
 - c. Study the implementation and assess the impact and benefits of Nai Roshni programme to the minority women and make recommendations for making it more effective and efficient.
 - d. Carry out base-line surveys of identified Minorities Concentration Areas (MCA) and identify the development deficits for implementation of PMJVK.
 - e. Impact assessment of the schemes being implemented by the Ministry and suggest measures for improvisation.
 - (ii) **Organizing Seminar(s)/ Conferences(s) on the following:**
 - a. Conduct awareness campaigns of the schemes of the Ministry, especially in MCAs to create awareness and give wider publicity of all the schemes of the Ministry.
 - b. Organize conferences/seminars to elicit views and opinions from the Muslim Communities for generating awareness and ideas for development of Waqf properties on sustainable commercial uses.
2. **The following organizations/institutions are eligible to submit proposal(s) under the aforesaid categories:**
 - a. Research Organizations/ Institutions/ Councils.
 - b. Registered Civil Societies under Societies Registration Act.
 - c. Universities including Deemed Universities recognized by University Grant Commission (UGC).
 - d. Reputed Institutions of Higher Learning.
 - e. Autonomous Bodies.
 - f. Reputed Market Research Agencies and Registered Bodies of Professionals.

In addition to the above, State Government(s) are also eligible to submit proposals under the category of organizing Seminar(s)/ Workshop(s)/ Conferences(s).
3. **The detailed Scheme Guidelines containing eligibility criteria, guidelines for formulating proposals, deliverables and other relevant information, including, prescribed format(s), are available on the Ministry’s website www.minorityaffairs.gov.in.**
4. **The proposal(s) may be sent either by Registered Post to the Under Secretary (R&M), Ministry of Minority Affairs, 11th Floor, Pt. Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi-110003, or submitted in person on the given address between 10.00 am to 05.00 P.M. on all working days.**
5. **The last date for submission of duly signed Proposal(s) in the prescribed format in the Ministry is 12th November 2018.**
