Sir,

In continuation to this Ministry's sanction letter of even number dated 12.02.2009, 08.01.10, 19.03.10, 29.03.10 and 31.03.11, I am directed to convey the sanction of the President for release of an amount of **Rs. 44,68,000/-** (**Rupees forty four lakh and sixty eight thousand only**) as 2nd instalment (50% of total central share) of the total sanctioned amount of **Rs. 89,37,000/-** (**Rupees eighty nine lakh and thirty seven thousand only**) for the year 2011-12 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for minority concentration districts (MCDs)" for Saharanpur district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government is advised to ensure that proportionate share of 50% of state share (i.e. Rs. 10.535 lakhs) for PHSC and ACR is released.

3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 - General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 – Grant for creation of capital assets for the year 2011-12.

4. A copy of the Utilization certificate of 1st instalment is enclosed. Further it is certified that no UC is pending for this programmme.

5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame, may also be furnished.

6. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
