- The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
- The State Government should ensure that a board containing information as per Template 6. enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed. 6. Michan
