As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects may also be furnished.
- villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

- 8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.
