2. The financial bid should be valid for a period of not less than 60 days from the date of opening of bid.
3. The bid should be inclusive of all taxes.
4. An EMD amount of Rs.10,000/- (Rupees ten thousand only) is to be deposited with the tender.
5. The tender should be accompanied with a copy of the signed in each page by the representative of the party.
6. The bid should be super scribed with FINANCIAL BID FOR PURCHASE OF ADOBE SOFTWARE” and addressed to the “Under Secretary (Admin), Ministry of Minority Affairs, 11th Floor, Paryavaran Bhawan, CGO Complex, Lodhi Road, New Delhi-110003”.
7. Bids will be opened in the presence of bidders’ representatives, who choose to attend on the specified date and time.
8. Sealed bids should be dropped in Ministry of Minority Affairs tender box kept at Ground Floor, Paryavaran Bhawan, CGO Complex, Lodhi Road, New Delhi-110003.
9. The Adobe Software’s are to be supplied within a period of 2 weeks from the date of issue of Purchase Order (PO) by the Ministry.
10. Payment will be released after successful delivery of the product.
11. The Ministry does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or in part without assigning any reason.
12. In case the reseller is not able to execute the Order, EMD amount of Rs.10,000/- (Rupees ten only) shall be forfeited.
13. In the event of dispute, the Under Secretary (Admin), Ministry of Minority Affairs, shall be the sole arbitrator and his decision shall be final and binding on both the parties.


