Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sector Development Programme for minorities to Government of **Uttar Pradesh for the year 2010-11 for Budaun District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 06.07.09, 11.03.10 and 29.03.10 for the release of 1<sup>st</sup> and 2<sup>nd</sup> installment, I am directed to convey the sanction of the President for release of an amount of **Rs. 10,32,50,000/- (Rupees ten crore thirty two lakh and fifty thousand only)** as 2<sup>nd</sup> installment for the year 2010-11 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for minorities" for Budaun district as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 - General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sector Development Programme for minorities, 04.00.35 - Grant for creation of capital assets for the year 2010-11.

3. A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that no UC is pending for this programme.

4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sector Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount may also be furnished.

5. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

6. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

7. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.

\*State Govt. of Uttar Pradesh has been sanctioned an amount of Rs. 1475.00 lakh for 1000 units of AWC which was approved in 12<sup>th</sup> EC meeting vide this Ministry's letter dated 06.07.09. Later on in the 35<sup>th</sup> EC, AWCs were reduced to 700 units on request of the State Govt. The total amount sanctioned to State Govt. of U.P. 700 units of AWCs including this sanction of Rs. 1032.50 lakh comes out to Rs. Rs. 2507.50 lakh as against Rs. 2065.00 lakh for 700 units of AWC. The excess amount of Rs. 442.50 lakh (Rs. 2507.50 lakh – 2065.00 lakh) is to be diverted to incur expenditure of the project of construction of polytechnic with two hostels amounting to Rs. 615.00 lakh for which an amount of Rs. 172.50 lakh (Rs. 615.00 lakh – Rs. 442.50 lakh) has been sanctioned vide sanction No. 3/19(8)/2008-PP-I dated 14.02.2011.
