I am directed to refer sanction letter of even no. dated 13.02.2014 whereby Rs. 147.92 lakh was released to the Govt. of Bihar for construction of Additional Primary Health Centres and Health Sub-Centre in Blocks and to convey the sanction of the President for release of additional amount of Rs. 41,91,000/- (Rupees forty one lakh ninety one thousand only) as 1st instalment to the Govt. of Bihar for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Blocks/Towns (MCBs/Towns) of West Champaran district as per the details enclosed at Annexure I. The State Government should ensure that proportionate share of of State share for the projects 2. mentioned at annexure-I is released to the implementing agency alongwith Central share.

The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" 3. Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 - Grant for creation of capital assets for the year 2014-15.

Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this 4. grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects may also be furnished.

The sanction is issued on the commitment given by the State Govt. that villages/locations having 5. a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.

9. This sanction issues with concurrence of IFD vide their Dy. No 396/IFD dated 05.08.14. It is noted at S. No. 88 in the Grant-in-aid Register.
