
Sir/Madam,

The scheme of Post matric scholarship for students belonging to minority communities was approved by the Competent Authority. Accordingly, the details of the scheme were communicated vide this Ministry's D.O. No. 9(1)/2006-PP.I dated 20.12.2007, to all the State/UT Government.

2 While approving the scheme, the Competent Authority had, inter-alia, approved that the proposed scheme may be kept at par with that of the scheme for SC/ST students and any revision of the rates for SC/ST students would automatically apply to the minorities, without the Ministry of Minority Affairs having to seek separate approval.

3 Ministry of Social Justice & Empowerment vide their letter no 11017/01/2008-SCD-V dated 31.12.2010 have since revised the maintenance allowance of Post matric scholarship for students belonging to Scheduled Castes w.e.f. 01.07.2010.

4 In accordance with para 2 & para 3, the rates of the maintenance allowance for ten months only in an academic year (includes expenses for study material etc.) under Post matric scholarship scheme for students belonging to Minority Communities are hereby revised as under :-


Category	Courses/item	Hosteller	Day Scholar
I.	XI and XII level (including technical and vocational courses of this level)	380	230
II.	Courses other than technical and professional courses at under graduate and post graduate level	570	300
III.	M.Phil and Ph.D (for those researchers who are not awarded any fellowship by university or any other authority)	1200	550

The Admission/tuition and Course fee and other features of the scheme remain unchanged.

5 The above rates would take effect from 01.04.2011.

6. This issues with the concurrence of Integrated Finance Division vide their Dy. No. 914/IFD dated 01.02.2011 read with IFD dy. No. 95/JS&FA/11 dated 17.02.2011.


