The payment will be made by Pay & Accounts Officer of the Ministry of Minority Affairs to CAP Foundation, 101, Gowri Shankar Residency, Plot No. 53 & 54, Kamalpuri Colony, Phase-III, Hyderabad -500073, Andhra Pradesh, A/c no. 008010100450522, IFSC Code no. 4. The release of funds is subject to fulfillment of the terms and conditions prescribed under the scheme guidelines, Memorandum of Understanding (MOU) signed between Ministry and organization and Bond furnished by the organization.
5. The organization shall guarantee Placement to all trained minority youths under this scheme with a minimum placement of 75% candidates and at least 50% out of them in organized sector.
6. The organization will provide Post Placement Support for period of one year and develop Management Information System as per scheme guidelines.
7. No UC is pending in the Ministry in respect of CAP Foundation.
8. The organization shall ensure commencement of project within 15 days of sanction of first installment and furnish list of trainees in the format prescribed.
9. The organization will submit the Progress Report and Utilization Certificate in GFR 19 (A), as prescribed in para 7 of the Scheme Seekho Aur Kamao.
